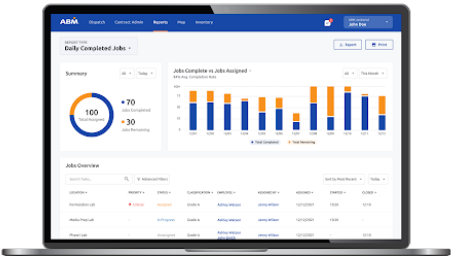
Chemical Tracking, Made Easy
